

# Cottenham Village Design Group

## Planning application comments

**S/2509/12/FL**

**Erection of 47 dwellings, garages, public open space, landscaping, vehicular access from Beach Road and associated infrastructure (Resubmission of S/2317/11).**

### Introduction

This comment from the Design Group relates to the recent resubmission of proposals for this site. Many of the comments the Cottenham Village Design Group wished to make were addressed during the previous application process however a few do remain and are shown following:-

### Comments

The Design Group was pleased that the majority of our previous comments for this site were addressed, our comments now centre on a few areas where we note particular concerns/ omissions. This document can be read in conjunction with our previous submissions, our comments are as follows:-

- Our comments regarding the treatment of the property boundaries to the street is one that remains unactioned, the Design Group would again request that property boundaries to the street are defined in a more typical Cottenham fashion by the use of either low walls or railings.
- On House Type G the use of an arch feature, unsupported over an open porch below, remains an odd detail. We had suggested that this house might be improved if the open porch could be filled in, but if the open porch design is to stay as we understand, then this house may read more correctly, figuratively and structurally, if this arch were now omitted.

### Conclusion

A great number of our initial concerns with these proposals have been addressed, however some minor areas of concern with the streetscene do remain.

*'C/1: Developers and planners should consult the Village Design Statement, which reflects the views of the community.'* (Design Statement p.2)

*'S/1: Settlement patterns are a key to the distinctive nature of the village. Developers should recognise this and respect the characteristic layout.'* (Design Statement p.7)

*'B/6: New developments should acknowledge their Cottenham context and avoid pattern-book designs. Developments can maintain and strengthen the visual cohesion of the village, and help to renew the specific architectural traditions of Cottenham.*

- *Refer to local settlement patterns in layout.*
- *Respect local characteristics and context of the particular site.*
- *Use good quality materials – whether modern or traditional – which are appropriate to Cottenham.*
- *Respond to typical settings and garden forms and avoid large areas of hard surfacing. (Design Statement p. 19)*

*'H/1: Roads should be designed first and foremost from a pedestrian and vulnerable road users' perspective.*

- *Particular emphasis should be applied to the core of the village.*
- *Consider alternative road surfaces which may help slow traffic. (Design Statement p.20)*

*'F/1: The streetscape needs a considered design approach employing professional landscape designers.*

- *Street furniture should suit its Cottenham context: designs of street lighting, for example, could renew the local tradition of metalwork.*
- *Simple designs are usually most appropriate.*
- *Gates and metal railings should generally be painted black.'* (Design Statement p.21)
